RESOLUTION REQUESTING FOR ONE (1) UNIT PATROL CAR AND FIREARMS FOR THE PNP, BOTOLAN, ZAMBALES.

WHEREAS, the Police Department of Botolan, Zambales is in need of one (1) unit patrol car and firearms which is very essential in the discharge of their functions to maintain peace and order in the Community;

WHEREAS, in the furtherance of their functions and considering the relative expanse of their jurisdiction, serving 31 barangays, the need for a vehicle to transport them in areas promptly needing help is lacking;

WHEREAS, some of their firearms are already out-modelled and are uncertain of serviceability, while many could still serve the purpose for which said firearms are issued, continuous firing during encounter may no longer be reliable;

WHEREAS, this will be a great blunt in extending basic services like patrolling hot areas to maintain peace and order or responding to call for police assistance and immediate security measures;
