RESOLUTION REQUESTING THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) FOR THE DISPERSAL OF FIFTY THOUSAND (50,000) TILAPIA FINGERLINGS IN THE COMMUNAL BODIES OF WATER SPECIFICALLY THE RIVERS/STREAMS/FISHPOND OF MAMBOG, SANTIAGO, PANAN, CARAEL, PAUDPOD, TAUGTOG, BATONLAPOC, SAN JUAN, BANCAL AND SAN ISIDRO

WHEREAS, fishing is one of the major sources of livelihood of the people in the Municipality of Botolan, being a town surrounded with different bodies of water;

WHEREAS, it is the declared policy of the local government unit to promote the well being of the people by undertaking a program of development which shall establish a community where people can live with food security;
