Whereas, RA 8972, An Act Providing for Benefits and Privileges to Solo Parents and their Children, Appropriating Funds Therefor and for other Purposes, otherwise known as the Solo Parents' Welfare Act, was enacted in 2000;

msy Section 5. Comprehensive Package of Social Development and Welfare Services which include livelihood development services, counseling services, parent effectiveness services, critical incidence stress debriefing and special projects.
