
Now therefore, upon motion of Honorable Marlo Thomas D. Doble, seconded by Hon. Oliver M. Olivares, and approved by all the members present.

Resolved as it is hereby resolved, to approve the contingency plan of the MDRRMC of Botolan, Zambales for implementation of the local government.


Resolved further, to furnish the Office of the Civil Defense with a copy of this resolution, for their information and appropriate action.




