Whereas, these cash for work projects and activities with long term impacts on the development of the physical and natural assets of the recipient-communities which includes, but limited to the following projects including mitigation measures such as rehabilitation of mangrove plantation, tree planting or reforestation activities, and rehabilitation of small-scale community infrastructure such as slope protection, desilting of waterways and others;

Whereas, the project aims to encourage the individuals listed in the Municipal Social Welfare Development Office (MSWDO) to work together for the preparation of the ill effects of climate change being seen around the world, secondary to prevent any erosion, and provide the same groups an opportunity to work for their respective daily food requirements through these projects.;

Whereas, the DSWD Field Office III, of San Fernando, Pampanga had allocated an amount of P3,508,120.00 for the implementation of cash for works (CFW) projects which will include the participation of 1,309 poor individuals to render time and effort for ten days, with an amount of P268.00 as daily rate;

Whereas, once the project is completed, the project beneficiaries had made such initiatives and measures to reduce the vulnerability of the natural or human system against actual or expected climate change effects. The adjustment in natural or human systems in response to actual or expected stimuli or their effects, will moderate harm or exploits beneficial opportunities;


Now therefore, on motion of Hon. Gregorio D. Jaring, and approved by all members of the Sangguniang Bayan,




