RESOLUTION NO. 01-2018

RESOLUTION REQUESTING THE REGIONAL DIRECTOR OF THE PHILIPPINE NATIONAL POLICE-REGION III TO ESTABLISH A 3RD MOBILE FORCE COMPANY IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, on the 23rd day of June 2018, an arson incident transpired at the Old Poonbato, Botolan, Zambales as reported by a concerned citizen to the PNP Station at 7:45 PM on the same day, leaving two (2) units of backhoe and one unit of bulldozer burned and damaged;

Whereas, witnesses attested that there were 30 armed men and women who arrived at the site of the on-going construction of Zambales-Tarlac road and introduced themselves as members of the Bagong Hukbong Bayan under Josefino Corpuz Command;

Whereas, after bringing the witnesses approximately 100 meters away from where the heavy equipment were situated, some armed men spilled gasoline on the equipment and put them into flame;

Whereas, this arson incident brought fear not only to the local residents of the said barangay but to the entire populace of Botolan as well;

Whereas, this will also cause tremendous and damaging effect to the tourism program of the local government as it will consequently thwart the tourists from coming in due to the impending threat to the peace and order in Botolan brought by the leftist group;

Whereas, the presence of a special enforcement group in the Municipality will assure the residents of a peaceful and orderly Botolan after the act of terrorism which transpired at Old Poonbato;

Now therefore, on motion of Hon. Atty. Edmund Dante D. Perez, seconded by Hon. Oliver M. Olivares, and approved by all the members present;
