Whereas, pursuant to Section 447 of the Local Government Code of 1991, the Sangguniang Bayan, as the Legislative Body of the Municipality shall pass ordinances and resolutions necessary for an efficient and effective municipal government, and in this connection shall maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition;

Whereas, the ratio of police personnel to the population of Botolan is small that it is extremely difficult to maintain peace and order in the municipality with 60,000 people;

Whereas, due to the inadequate number of police officers who are responsible for public safety and law enforcement, it is deemed necessary to request for additional police force;
