RESOLUTION GRANTING AUTHORITY TO HON. DORIS E. MANQUIZ, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION (POEA), OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)-REGION III, AND TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) FOR THE IMPLEMENTATION OF THE CAMPAIGN PROGRAMS AGAINST RECRUITMENT MALPRACTICES SUCH AS ILLEGAL RECRUITMENT AND TRAFFICKING IN PERSONS AND CONDUCT OF CAPABILITY ENHANCEMENT TRAINING, IN THE MUNICIPALITY OF BOTOLAN

Whereas, the aforesaid agencies will also conduct anti-illegal recruitment and trafficking in persons training for law enforcers as part of the campaign against illegal recruitment in this municipality;




