**Whereas**, Memorandum Circular No. 2015-128 which was issued on November 2, 2015 by the Department of the Interior and Local Government (DILG) provides for the “Guidelines in the Formulation of the Peace and Order and Public Safety (POPS) Plan”;

**Whereas**, pursuant to Section 116 of Republic Act No. 7160 also known as the Local Government Code of 1991, and Executive Order No. 773, s. 2009 which calls for the future reorganization of the Peace and Order Councils, every province, city and municipality is mandated to create Peace and Order Council. Likewise, every barangay pursuant to E.O. No. 366, s. 1996 is mandated to create a Barangay Peace and Order Committee as the implementing arm of the city/municipal POC;
