**RESOLUTION AUTHORIZING HON. DORIS E. MANQUIZ, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE IMPLEMENTATION OF THE COMMUNITY-BASED MONITORING SYSTEM (CBMS) IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES**

**Whereas**, the Community-Based Monitoring System (CBMS) is an organized technology-based system of collecting, processing and validating necessary disaggregated data that may be used for planning, program implementation, and impact monitoring at the local level while empowering communities to participate in the process;

**Whereas**, the Philippine Statistics Authority shall be the lead agency in the implementation of the CBMS and the Department of the Interior and Local Government is tasked to develop and implement information and education campaign relating to CBMS, ensure compliance of the LGUs in the various CBMS activities and extend assistance to PSA in the conduct and implementation of the CBMS;

**Whereas**, the CBMS shall serve as an economic and social tool towards the formulation and implementation of poverty alleviation and development programs which are specific, targeted, and responsive to the basic needs of each sector of the community;

**Now therefore**, on motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Aris George D. Lingat, and approved by all the members in session assembled;

**Resolved**, as it is hereby resolved, to authorize Hon. Doris E. Maniquiz, Municipal Mayor, to enter into a memorandum of agreement (MOA) with the Philippine Statistics Authority (PSA) and the Department of the Interior and Local Government (DILG) for the implementation of the Community-Based Monitoring System (CBMS) in the Municipality of Botolan, Zambales.
