RESOLUTION AUTHORIZING THE USE OF THE SANGGUNIANG BAYAN GROUP CHAT AS THE OFFICIAL MEANS OF COMMUNICATION OF THE VICE MAYOR/PRESIDING OFFICER, HONORABLE MEMBERS OF THE SANGGUNIANG BAYAN, AND THE SECRETARY TO THE SANGGUNIAN, FOR OFFICIAL MATTERS ONLY

Whereas, effective communication among the Vice Mayor, Sangguniang Bayan (SB) Members and the SB Secretary is essential for the efficient functioning of the local Legislative Body;

Whereas, modern technology provides convenient and efficient methods of communication that can enhance collaboration and streamline official communications;

Whereas, a group chat platform has been proposed as a practical and immediate means for the Vice Mayor, SB Members, and the SB Secretary to communicate on official matters;

Whereas, the official group chat shall be created on a secure and widely accessible messaging platform, which shall be determined and managed by the SB Secretary or a designated administrator;

Whereas, the use of the official group chat is strictly limited to discussions, announcements and exchanges related to official legislative business, such as meeting schedules, agenda items, resolutions, ordinances and other relevant matters;


Resolved further, that a copy of this resolution be furnished all concerned agencies and departments for their information and appropriate action.




