**RESOLUTION NO. 88-2023**

**RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL GRID CORPORATION OF THE PHILIPPINES (NGCP) FOR THE IMPLEMENTATION OF THE CORPORATE SOCIAL RESPONSIBILITY PROGRAM BY PROVIDING LIVELIHOOD ASSISTANCE TO THE MICRO-ENTERPRISES IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES**

**Whereas**, the LGU-Botolan is host to NGCP facilities located in Barangay Santiago, and has been identified as one of the beneficiaries of NGCP's Community Upskilling and Enterprise Development (CUPED) Project that shall provide livelihood packages to chosen beneficiaries from the food industries particularly the convenience (sari-sari) stores, rice business (bigasan), and eatery (carinderia);

**Whereas**, NGCP, through its Corporate Initiatives and Advocacies Division (CIAD), is committed to implement its Corporate Social Responsibility by providing livelihood assistance to the micro-enterprises situated in communities that host the NGCP's power transmission lines and facilities;

**Whereas**, the NGCP shall procure the livelihood packages, inform the LGU-Botolan about the mechanics of the CUPED Project, and the Department of Trade and Industry's (DTI's) role in the implementation thereof, review the list of beneficiaries to be endorsed by the DTI and LGU-Botolan, coordinate with the DTI, LGU-Botolan, and the concerned barangays for the necessary requirements, monitor the preparatory works, coordination, implementation, project-end report, and assessment of the CUPED Project;

**Whereas**, the LGU-Botolan shall identify the number of forty (40) beneficiaries, prioritizing those who reside in NGCP host barangays, coordinate with DTI in the identification, profiling, and submission of recommended beneficiaries, lead the coordination activities with the concerned barangays and conduct an orientation with the target beneficiaries, ensure the completeness of the needed documentation from the beneficiaries;



**Resolved, as it is hereby resolved** that the Sangguniang Bayan of Botolan hereby grants authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a memorandum of agreement with the National Grid Corporation of the Philippines (NGCP) for the implementation of the corporate social responsibility program by providing livelihood assistance to the micro-enterprises in the Municipality of Botolan, Zambales.
