#### **RESOLUTION NO. 05-2024**

RESOLUTION PROVIDING SUPPORT FOR THE PASSAGE OF HOUSE SUBSTITUTE BILL ON MAGNA CARTA FOR PUBLIC DISASTER RISK REDUCTION AND MANAGEMENT WORKERS IN THE  $19^{TH}$  CONGRESS

Whereas, since the enactment of Republic Act No. 10121, also known as the Philippine Disaster Risk Reduction and Management Act of 2010, no legislative action has been taken to safeguard the welfare, socio-economic, and psychological well-being of public Disaster Risk Reduction and Management workers;

Whereas, the drafting of the Magna Carta for Public DRRM workers Bill in 2021 was initiated by the Office of the Civil Defense (OCD), resulting in the bill being sponsored in the 19<sup>th</sup> Congress by the House of Representatives;

Whereas, the proposed legislation seeks to improve and strengthen the socio-economic welfare, living and working conditions, employment terms, and the skills and capabilities of individuals involved in the field of Disaster Risk Reduction and Management (DRRM);

Whereas, these improvements encompass a range of elements, such as raising the position of the Local Disaster Risk Reduction and Management (DRRM) Officer to that of a department head within the Local Government Unit, creating implementing rules and regulations to delineate the organizational framework, personnel composition, and salary benchmarks for local DRRM Offices, and securing a lasting exemption from the Personnel Services Limitations imposed on LGUs, among other stipulations;

Now therefore, upon motion of Hon. Fernando D. Oñate, Jr. seconded by Hon. Eddie D. Daos, and approved by all the members of the Sanggunian in session assembled;

Resolved, as it is hereby resolved to express the full and unwavering support for the enactment of the Magna Carta Bill for Public DRRM Workers;

Resolved further, that a copy of this resolution be furnished all concerned agencies and departments for their information and appropriate action.
