MUNICIPAL ORDINANCE 05-2025

AN ORDINANCE REZONING LOT 64, CAD 614-D, THE AREA OF OLD MUNICIPAL HALL LOCATED AT TAMPO, BOTOLAN, ZAMBALES CONTAINING AN AREA OF ONE THOUSAND NINE HUNDRED SEVENTY SQUARE METERS (1,970) FROM INSTITUTIONAL TO COMMERCIAL USE

Whereas, the Local Government Code of 1991 (Republic Act No. 7160) empowers local government units to enact zoning ordinances in accordance with the Comprehensive Land Use Plan (CLUP) and to promote the general welfare of their constituents;

Whereas, the area located at Barangay Tampo, Botolan, Zambales formerly utilized as the Old Municipal Hall site, has an area of one thousand nine hundred seventy (1,970) square meters and is currently classified as an institutional zone;

Whereas, the said property is no longer used for its original institutional purpose and is deemed more suitable for commercial development to better serve the economic needs and growth objectives of the municipality;

Whereas, upon proper consultation, public hearing, and recommendation of the Municipal Planning and Development Officer, it has been found appropriate to rezone the area to support local economic development;

Now therefore, on motion of Hon. Marlo Thomas D. Doble, Chairman of the Committee on Land Utilization, seconded by Hon. Dr. Fernando D. Igrobay, duly approved by all the members in session assembled:

Be it ordained by the Sangguniang Bayan of Botolan in session, that:

Section 1. Title

This ordinance shall be known as AN ORDINANCE REZONING THE AREA OF OLD MUNICIPAL HALL LOCATED AT TAMPO, BOTOLAN, ZAMBALES CONTAINING AN AREA OF ONE THOUSAND NINE HUNDRED SEVENTY SQUARE METERS (1,970) FROM INSTITUTIONAL TO COMMERCIAL USE

Section 2. Rezoning

The parcel of land formerly occupied by the Old Municipal Hall located at Barangay Tampo, Botolan, Zambales with a total area of 1,970 square meters, is hereby reclassified from Institutional Use to Commercial Use in accordance with the Comprehensive Land Use Plan and Zoning Ordinance of the Municipality of Botolan.

Section 3. Purpose

This rezoning is intended to encourage commercial development, promote local economic activity, and maximize the utility of idle government-owned properties.

Section 4. Implementation

The Municipal Planning and Development and Zoning Administration Office shall ensure the proper updating of the zoning map and all relevant records to reflect this change. All commercial developments within the area shall be subject to applicable national and local regulations, permits and clearances.

Section 5. Separability Clause

If, for any reason, any provision of this Ordinance is declared unconstitutional or invalid, the remaining provisions not affected shall continue to be in full force and effect.

Section 6. Repealing Clause

All ordinances, resolutions, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 7. Effectivity

This Ordinance shall take effect upon approval and compliance with the posting and publication requirements under existing laws.
