MUNICIPAL ORDINANCE 07-2025

AN ORDINANCE DECLARING THE FOURTH (4TH) WEEK OF NOVEMBER AS "BOTOLEÑOS YOUNG ENTREPRENEURS WEEK" IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES

Whereas, Section 2 of R.A. 8044, Series of 1995 or the "Youth in Nation-Building Act" provides for the encouragement of youth involvement in character building, development activities for civic efficiency, stewardship of natural resources, agricultural and industrial activity and participation in structures, policy-making and program implementation to reduce poverty incidence and accelerate socio-economic development;

Whereas, the National Youth Commission (NYC) pursuant to its mandate under R.A. 8044 has formulated the Youth Entrepreneurship Program which aims to develop the entrepreneurial skills of the youth and encourage them to participate and organize business enterprises;

Whereas, the private business sector plays a critical role in ensuring the success of the programs on entrepreneurship;

Now therefore, upon motion of Hon. Jay T. Dilag, Chairman of the Committee on Market, Trade and Industry, seconded by Hon. Eddie D. Daos, and approved by all the members in session assembled, that;

Section 1. TITLE. This Ordinance shall be known as the "Botoleňos Young Entrepreneurs Week".

Section 2. DECLARATION OF POLICY, It is hereby declared the policy of the State to promote the sustained development of young Filipinos whose aptitude and skill in the field of finance and entrepreneurship shall be encouraged and honed through education and specialized training programs.

Towards this end, the State shall establish, maintain and support a complete, adequate, and integrated system of education and training to encourage the entrepreneurial spirit among our youth as well as support and promote the growth of young entrepreneurs nationwide.

Section 3. DEFINITION OF TERMS. As used in this Ordinance, the following terms shall mean:

- a. Local Young Entrepreneurs Any youth who organizes and operates his/her own small or big business that is located in the Municipality of Botolan, Zambales.
- b. Botoleños Youth residents of Botolan, aged 15-30 in consonance with R.A. 10742.

Section 4. PURPOSE. This Ordinance aims not just to celebrate the week for local young entrepreneurs of the Municipality of Botolan but to inform the public of their existence. This will give them an avenue to showcase their businesses through their offered service, crafts, skills and products. This will also be a way to show that the local government of Botolan with its promise to promote the general welfare of the youth fully supports start-up businesses owned by the young people. This also aims to help the young entrepreneurs to be fully equipped with things they should know about the business world. Finally, this would help inspire the Botoleňo Youth to start their own businesses.

Section 5. SCOPE. The declaration of the 4th week of November as the "BOTOLEÑOS YOUNG ENTREPRENEURS WEEK" involves all the youth residing in the Municipality of Botolan, especially the young entrepreneurs and the youth who own businesses.

Section 6. IMPLEMENTING BODY. The Local Youth Development Office (LYDO) shall include in its annual investment programs the celebration of the Botolenos Young Entrepreneurs Week and appropriate funds thereof to facilitate the programs and activities, such as but not limited to the following:

- 1. Trade Fairs
- Seminar Workshops on trade policies, marketing and promotions and product development
- 3. Financial Literacy

Section 7. EFFECTIVITY. This Ordinance shall take effect after 21 days from the date a copy is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other prominent places in the Municipality of Botolan.
